TOURNAMENT RULES - ENTRY FORM

- 1. These Rules apply to all entrants of the tournament. Violation of any of these rules will warrant appropriate disciplinary action by Tournament Director. Any protest must be received in writing and signed within 15 minutes of final check-in deadline to be taken literally. Tournament Directors reserve the right to refuse entry of any person. Ignition Bass and HCPOA Tournament Committee decisions will be final in all matters.
- 2. Team Entry Fee is \$100 (70% payback) and Big Bass is an additional \$10 per team (100% payback). No refunds of entry fees unless approved by the Henderson County POA Tournament Committee on a case-by-case basis, and only if requested prior to the start of the Tournament. One place will be paid for every 5 team entries.
- 3. State, Federal, and Local Laws must be obeyed at all times. All Entrants are subject to take a Polygraph Test. Failure to take and/or pass such a test will result in disqualification. Any person who has failed a polygraph test in connection with any bass tournament for cheating will not be eligible to fish in this Tournament.
- 4. Firearms are not allowed in tournament boats during tournament hours or carried during registration or weigh-in. Law Enforcement Officers are the only exception to this rule.
- 5. Alcohol and Narcotics will not be allowed in the possession of contestants during tournament hours, unless prescription medicine. Alcoholic beverages are prohibited by City Ordinance in the Log Cabin City Park and Boat Ramp areas.
- 6. Courtesy, Safe Boating, Sportsmanship and Conservation must be displayed at all times by contestants. A U.S. Coast Guard approved chest type PFD must be on and fastened anytime the combustion engine is in gear. All boats must meet U.S. Coast Guard standards. Jet-drive, air-cooled engines, or air-boats are not allowed. Outboard motors may not exceed boat manufacturers rating. All boats must have an emergency kill-switch and must be attached to the driver anytime the combustion engine is in gear. No more than two persons per boat and both persons in a boat must be registered contestants.
- 7. All fishing must be done with artificial lures only. Pork is permitted. Only one rod and reel may be used at a time by contestants. No trolling with the combustion engine is allowed. All fish must be caught in a legal and sporting manner during tournament hours from tournament waters. Contestants may not use any communication device to contact non-contestants for the purpose of locating or catching bass during tournament hours. Tracking devices inserted in bass may not be used by any contestant during or before the tournament. Hole-Sitting by or for entrants is not allowed.
- 8. Off limits Period of the lake for fishing, scouting, locating any bass, including shoreline spotting will begin at sundown on the night before the tournament. Boat stalls, slips, or beaching of boats is allowed on the night before a tournament for convenience and easing of traffic at host marina.
- 9. Boats must have a permanently installed live well and an operating aeration system. Teams may keep no more than 5 bass in the live well.
- 10. Scoring will be determined by the total weight of not more than 5 bass per Team at least 14" in length. Fish will be measured on a measuring board approved by the Tournament Director with the tail closed. Ties for cash prizes will be settled by combining two cash awards and splitting the total between tied anglers.
- 11. No fishing is allowed within 25 yards of another tournament boat without mutual consent. No fishing is allowed within 25 yards of any manmade structure of the host marina. No tube, bank, or wade fishing is allowed. Contestants may not leave the boat to gain access to fishing waters.
- 12. Trailering to and from the weigh-in during tournament hours is not allowed, unless permitted by the Tournament Director for safety or emergency reasons. All fishing must be from a previously inspected boat.
- 13. Registration may be made at take-off site on morning of the tournament beginning at 5 a.m. Contact Wayne Nutt Jr. (903) 286-3594 for additional times and locations, if any. Entrants will receive boat I.D. numbers according to order received.
- 14. Tournament Hours and Check Points will be given at registration and are the responsibility of each entrant. Any boat ramp may be used, however all boats will take-off in a numbered order at first safe-light from host marina (unless otherwise instructed by Director). Weigh-In may be staggered in flight intervals. NOTE: BOATS WILL NOT TAKE OFF UNTIL AFTER IGNITION BASS CHAMPIONSHIP TEAMS TAKE OFF.
- 15. Fishing Guides who have guided for black bass on tournament lake during three-months (90 days) prior to tournament and Anglers who participated in a National Professional Circuit during the previous year will not be eligible to compete.
- 16. Upon entering this fishing tournament, contestants release IGNITION BASS, Ian Coleman and other Ignition Bass officials, Henderson County Peace Officers Association and its members, the City of Log Cabin, and any and all sponsors, volunteers, etc. from liability of accidents, losses or thefts. Contestants are responsible for knowing and understanding these rules and knowing all applicable Texas boating & fishing laws.

17. Penalties: There will be a 1/2 (.5) pound penalty deducted for each dead fish weighed-in. There will be a two (2) pound penalty deducted for any fish not meeting the predetermined size requirement (14") brought to the scales, plus loss of short fish. Additional Penalties are considered for
